Bee Disease Insurance (BDI) covers losses due to the notifiable bee diseases. Insurance for THREE colonies (Scheme A) is included in your subscription. Special terms are available for members with forty or more stocks (Scheme B). Please ensure that **ALL** your planned colonies are covered, including nucs and mini-nucs, as BDI rules state that if you under-insure you would not receive **ANY** compensation.

The Spray Liaison Scheme enables farmers to warn beekeepers of their intention to spray plants on which bees may be foraging. Please list **ALL** the parishes in which you keep bees in order that you may be notified if spraying is being conducted in your area. _____

GIFT AID DECLARATION / CONTACT DETAILS

From April 6th 2000 charities are able to reclaim the tax on gifts of any amount from donors who are UK taxpayers and have completed a simple Gift Aid Declaration. The Government has introduced these measures to boost charitable giving in the country. 'Getting Britain Giving' is the title of the initiative.

Taxpayers making a donation to the Association can increase the value of their gift substantially. Completing the Gift Aid Declaration below will enable the branch to reclaim from HMRC the tax paid on any donation.

This means that for each membership subscription of £30.00 the North Devon Branch can claim some **£7** for Branch funds from the Inland Revenue and **at no extra cost to the member.**

Please will all Members complete a GIFT AID DECLARATION, even if you have previously completed a covenant form or you are not a UK taxpayer, as this will help us with administration.

If you have any queries, or require assistance in completing this form, please contact the Branch Treasurer or Membership Sec. If you do not pay Income or Capital Gains Tax, or do not wish to use Gift Aid, please cross out "wish" below but still complete your full contact details.
